- i. Curriculum
  - 1. AP Government

Recommend purchase from Perfection Learning for a total amount not to exceed \$46,691; includes a 10% contingency; funded from ESSER funds and curriculum funds; place this on the next Board of Education meeting on the Consent Calendar.

2. AP World

This purchase is a six year extension of the current AP World curriculum resource materials.

Recommend purchase from McGraw Hill for a total amount not to exceed \$50,726; includes a 10% contingency; funded from ESSER Funds; place this on the next Board of Education meeting on the Consent Calendar.

3. Elementary Social Studies

The request follows a two-year adoption process of reviewing curricular resources and piloting different materials.

- Recommend purchase for grades K-2 Scholastic Classroom Magazine from Scholastic for a total amount not to exceed \$80,147; includes a 10% contingency; funded from ESSER funds and curriculum funds; place this on Discussion at the next Board of Education meeting.
- Recommend purchase for grades 3-5 Scholastic News Magazine from Studies
  Weekly for a total amount not to exceed \$109,771.20; includes a 10%

# contingency; funded from ESSER funds and curriculum funds; place this on Discussion at the next Board of Education meeting.

- ii. Capital Projects
  - **1.** Great Start Readiness Program (GSRP) Long Lake Restroom Addition This project is to construct a new classroom restroom and exterior door at Long Lake Elementary.

Recommend to award contract to Eckler Building Solutions for a total amount not to exceed \$74,580; includes a 10% contingency; funded from child care funds and GSRP funds; place this on the next Board of Education meeting on the Consent Calendar.

- iii. Transportation
  - 1. Facility Vehicle

This purchase is for a specialized vehicle for the licensed plumber.

Recommend to purchase from Lunghamer Ford in Owosso, Michigan for a total amount not to exceed \$43,292; includes a 10% contingency; funded from general fund; place this on the next Board of Education meeting on the Consent Calendar.
